

Inyova AG ('Inyova') is currently running a promotion with neon Switzerland AG ('neon'), where neon customers can benefit from an exclusive offer with Inyova 3a.

1. What is the promotion

If you (a neon customer who is not yet an Inyova customer) open a 3a account with Inyova 3a between the 01.11.2024 at 00.00 am and the 31.01.2025 at 11.59 pm by using the special neon code and following the steps described below, you will receive CHF 50 as a welcome gift on your neon account.

Alternatively, if you (a neon customer who is not yet an Inyova customer) invest or transfer an existing 3a from another provider to Inyova 3a **between the 01.11.2024 at 00.00 am and the 31.01.2025 at 11.59 pm** with a minimum amount invested/transferred of CHF 10,000 you will get **0.5% of the invested/transferred amount** added to your neon account. For example, if you invest/transfer an existing 3a account of CHF 15,000, you will receive CHF 75 (0.5% of CHF 15,000) into your neon account.

2. How to benefit from the promotion

- 1) You need to go to inyova.ch/en/3a-neon/ and create an Inyova 3a strategy.
- 2) When creating your account with Inyova and <u>before</u> investing you need to enter the code **neon3a** in your Inyova Dashboard under "Promotions".

- 4) You need to open a 3a account before **31.01.2025** at **11.59** pm which means you need to be an Inyova 3a invested customer and have transferred at least CHF 1,000 to your 3a account by that date. The same date applies to the alternative offer of the 0.5% reward, with the exception that a minimum amount CHF 10,000 must have been transferred to your Inyova 3a account by this date.
