



2% Cash Back promotion for neon customers opening a new Inyova Grow account

Terms and Conditions

1. What is the promotion?

Inyova AG (“Inyova”) is offering a **2% cash back promotion for neon customers opening a new Inyova Grow** account. This applies to individuals who as of 20/05/2025 at 00:00 am either:

- Are not an Inyova customer yet, or
- Have an Inyova Invest, Inyova for Kids, or Inyova 3a account but not yet a funded Inyova Grow account.

To qualify, you must open and fund a new Inyova Grow account, enter the promo code “neonGrow” in the Inyova Dashboard, and invest CHF 2,000 or more in green projects between 20/05/2025 at 00:00 am and 31/07/2025 at 11:59 pm. (Note: For the purpose of these Terms & Conditions, ‘invest’ refers to committing to invest or completing an investment.)

Example: If you follow the steps above and invest CHF 15,000 in green projects with Inyova Grow by 31/07/2025 at 11:59 pm, you'll receive a cash back of CHF 300.

2. How to benefit from the promotion?

- 1) Open a new Inyova Grow account and fund it.
- 2) Enter the promo code “neonGrow” in the Inyova Dashboard.
- 3) Invest in green projects through Inyova Grow between 20/05/2025 at 00:00 am and 31/07/2025 at 11:59 pm. The timestamp of your commitment to a project investment will determine eligibility.
- 4) Cash Back: If your total investments in green projects are CHF 2,000 or more, you'll receive 2% cash back on the total investments. The total CHF value of investments will be calculated using the spot exchange rates from 31/07/2025, as reported by the [Swiss National Bank](#). Please note that investments canceled under the right of withdrawal will not count toward the total amount for the promotion.
- 5) Cash Back Payment: The reward will be credited to your Inyova Grow account by 31/08/2025.

Eligibility:

- 1) This promotion is only open to new Inyova Grow customers who do not yet have a funded Inyova Grow account as of 20/05/2025 at 00:00 am.
- 2) You must have your domicile or permanent residence in Switzerland and be of legal age.
- 3) Each participant can only use the promotion once. The participant will be identified using their full name and date of birth (not email).
- 4) This promotion cannot be combined with any other offers or promotions.
